Undersøgelse og måling af kommunikationen mellem patienter og sundhedspersonalet i Rwandas primære sundhedstjeneste.

Effektiv kommunikation er essentielt for at opnå sundhedsydelser af høj kvalitet. I dette PhD-projekt undersøger to kvalitative studier henholdsvis patienters og sundhedspersonalets opfattelser af kommunikationen mellem dem. I et tredje studie beskrives udvælgelsen, tilpasningen og valideringen af et spørgeskemaværktøj til måling af sundhedspersonalets kommunikationsfærdigheder set fra patientens side. Fundene diskuteres i lyset af en rkke teorier og modeller, herunder modellen om"patient-centreret behandling". Projektet er gennemført af Vincent K. Cubaka, der forsvarer det d. 25/08/2017.

PhD defence. Patient-provider communication in Primary health care in Rwanda

Effective communication is essential to high quality health care. Two qualitative studies respectively explore patients and providers insights on patient-provider communication in Primary health care in Rwanda. A third study reports on the process of selection, adaptation and validation of a tool to measure providers' communication skills from a patient perspective. Findings are discussed in light of



the current communication theories and models, including the leading patient-centred model. The project was carried out by Vincent K. Cubaka, who is defending his dissertation on 25/08/2017.
